Goodrich Gallery is pleased to announce the call for entries for an exhibition of art featuring the Cross. The exhibit will open on Palm Sunday, March 28, 2010, continuing through April 26, 2010.

<b>April 27, 2010</b>	Pickup of Art Work, 1 - 3 p.m.

## **ELIGIBILITY**

- Open to Texas artists, 18 and over.
- Only one entry per artist will be accepted.
- Two-dimensional work must be dry, framed and ready to hang with single hole strap hangers (or screw eyes) and wire.
- Watercolor and other fragile media must be under Plexiglas.
- Pastel artwork may be under glass.
- Maximum overall frame size is not to exceed 48" in any direction.
- Gallery wrapped canvas is acceptable.
- Artwork must be original, executed without instructor supervision.
- Artwork must not be copies of artwork on photographs by persons other than the artist.
- Artwork not have been previously shown in Goodrich Gallery.
- Works which differ from the image submitted may be disqualified.
- Acceptable media includes: paintings, drawings, pastel, fiber art, photography and sculpture.

## **REGULATIONS**

- Artwork must depict the artist's interpretation of the cross of Christ.
- The artwork will be chosen by the Goodrich Gallery Jury Committee Members.
- Artists will be notified in writing if their artwork is accepted.
- Work may be for sale with the Gallery retaining a 15% commission.
- Work may be submitted NFS (not for sale).
- Entries shall imply the artist's acceptance of the above policies.
- If selected, entrants are obligated to exhibit their work during the entire show.

## **IMAGE TRANSMISSIONS**

- Art images for this exhibition should be submitted as:
  - 2" x 2" slides
  - JPEG file on CD
  - TIF file on CD
- Mark slides with "TOP FRONT", artist's name, title, price, medium and sizes.
- CD files must include an index containing image file name, artist's name, title, price, and sizes.
- Sculpture entries should submit two front and side images.

- Individual file sizes must not exceed 1.2 MB.
- Images should show only the art, not matting or frame.
- Image must accurately represent the artwork without enhancements.

**DELIVERY AND PICK UP OF ARTWORK ACCEPTED FOR THE EXHIBIT**

- Friday, March 19, 2010 Artists will hand deliver artwork between 10:00 a.m. and 12:00 p.m. to the Music and Arts Office at: First United Methodist Church

- If an artist is unable to hand deliver their work, they may designate an agent to act on their behalf.
- Monday, April 26, 2010 Exhibit closes at 5:00 p.m.
- Tuesday, April 27, 2010 All art work must be picked up in the Gallery between 1:00 p.m. and 3:00 p.m.
